I should like to be allowed to state to you the reason why I have resigned my position as Head of the Department of Infants and Junior School Teachers in the City of Leeds Training College.

I had before this spoken to Mr. Graham about my desire to take up educational work of a rather different character when opportunity should offer but this was not my immediate reason for resigning my post.

I have resigned at this time because of the change in conditions at the College which the Vice-Frincipal's resignation seems to me to involve.

Whatever arrangements may be decided upon for next year, I could not fail to find myself:- were I to remain - in what would be to me a very undesirable position. Should another Vice-Principal be appointed under conditions similar to those which have controlled the situation during the last three years, I could not but look forward to a repetition of what has occurred with the accompanying hampering of the whole work of the College.

Should no responsible Vice-Principal be appointed in our College which even in normal times contains such a large preponderance of women students. I feel I could not co-operate unreservedly with such a policy, and this would make my own work unsatisfactory to all concerned.

I have, therefore, felt obliged to send in my resignation, although I have done so with the most genuine and deep regret.

Previous to the receipt of the resignations, no complaint or grievance had been forwarded to the Governors; and as the reasons given for the resignations were so vague, the Chairman of the Education Committee asked the resigning members of the Staff to formulate a definite and detailed statement as to any cause of complaint they had. No such statement has been received except from Miss Owen. The resignations, after careful consideration were accepted by the Governors on the 21st June, and confirmed by the full Education Committee on 28th June.

The Governors have given the most careful consideration to this matter, and they are convinced that, in the circumstances, the acceptance of the resignations was in the best interests of the College; and the Board may rest assured that the Governors will ensure that the efficiency of the College, in all departments of its work, is maintained.

Elst June: Miss Walford and Miss Clapham, two members of the staff who had resigned, interviewed the Chairman of the Education Committee to ask whether he had any objection to the two letters of the 17th June (a) that signed by the seven members of the staff, and (b) that signed by Miss Owen, being sent by them to the Members of the Education Committee. The Chairman informed them that this was a matter within their own discretion. The Chairman took advantage of their visit to ask them to state explicitly wherein lay their objection to the policy and ideals of the Governors as expressed by the Secretary for Education. To this they replied that they would rather consult their colleagues.
- 9. 21st June. The resignations of the nine members of the staff were accepted by the Governors.
- 10. 22nd June: The letters of the 17th June to the Chairman, signed by seven members of the staff and that of Miss Owen, were sent to the Press, without copies of the Chairman's replies.

The "Yorkshire Post" telephoned the Chairman, who felt that the letters, if published, should not appear without his replies. He, therefore, dictated over the telephone, the replies he had sent, with the consequence that the Chairman's replies appeared in the "Yorkshire Post", with the letters from the staff, whereas in the other papers, only the letters from the staff appeared.

11. 23rd June: A paragraph appeared in the "Yorkshire Post" to the effect that an opportunity had been given to Miss Mercier by the "Yorkshire Post" to place her side of the question before the public, but she said that she desired to say nothing at present.
