2nd Meeting. A meeting of the Committee was held in the Dorchester Hotel on Friday, 16th. February, 1945.

Dr. Rich was in the chair and all members of the Committee were present.

The Minutes of the last meeting having been read and confirmed, it was reported that notices relating to the Testimonial Fund had been inserted in "The Yorkshire Post" and "The Schoolmaster", but that a notice in "The Teachers' World" had been withheld until it was known what response had been made to the other two appeals. It was also reported that circular letters had been sent to former members of the Staff and to all the Leeds schools, drawing attention to the Fund.

The Treasurer (Miss Irebas) stated that subscriptions to date amounted to £21. 4s. 6d. The expenditure of £2. 5. 10d. left a balance of £18. 18. 8. with outstanding subscriptions from Staff + Students which would probably bring the balance to about £20.

Dr. Rich reported that he had discussed the presentation with Miss Simpson, who had expressed a desire that the bulk of the money should go to the larger, permanent fund, but had also welcomed the idea of a personal gift, - a standard lamp or a travelling rug being mentioned.

After some discussion it was resolved that Miss Irebas consult with Miss Simpson regarding the present, and that a maximum of £10 be made available for the purchase thereof.

3rd Meeting. A meeting of the Committee was held in the Dorchester Hotel on Monday 26th. March. 1945.

Present.

Dr. Rich (in the chair), Miss Fatt, Miss Treloar, Miss Sanderson and Mr. Woodhouse. An apology for absence was received from Miss Dresser.

The Minutes of the last meeting were read and confirmed and Miss Treloar presented a financial statement which showed that subscriptions to date amounted to £47. 7. 11d. and expenses £13. 1. 1d. leaving a Balance in hand of £34. 6. 10d. It was reported that the lamp presented to

Miss Simpson had cost £6.17.6d and that a cheque for £3.3.0 had been paid to Miss Simpson towards the cost of a shade.

Miss Ince reported that in fact Miss Simpson had paid £5.5.0 for the shade, and it was therefore

moved & carried that a further £2.2.0 be paid to Miss Simpson to cover the total cost of the shade.

It was agreed that, in the light of the poor response to the published appeals, an advertisement should not be published in the Teachers' World.

The question of investing the balance of the funds was discussed at some length, and it was finally decided that no further action be taken until next term.

The meeting then closed.
